## **Recent developments:**

- The NW Section and the WA Department of Commerce hosted the April 28, 2016
   Spring Planner's Forum with a special focus on Critical Areas issues and updates. It was the largest attendance in NW Section history and the venue had to be changed from Burlington City Hall to the Skagit PUD to accommodate the 75 RSVPs.
- Anthony Boscolo now works for WSDOT and is no longer our NW Section liaison from the Department of Commerce. When asked, Commerce stated that no replacement has been identified and no timeline has been established for a replacement. Anthony provided a huge amount of support and this has led the NW Section Board to cancel the July 21 Planner's Forum in Ferndale.
- As a result of the membership survey administered by Communications Coordinator Beckye Frey, the NW Section Board voted to use \$300 to help host a "Curbside Chat" by Strong Towns founder Charles Marohn on Thursday, October 20, 2016 in Bellingham. This is the same date as the scheduled Autumn 2016 Planners Forum, so the NW Section Board also voted to change the location of the Autumn 2016

Planner's Forum to Bellingham. We will be updating the Planner's Forum schedule on the web site as soon as possible.
