**Purpose:** To provide financial support for an actively enrolled Huxley undergraduate in the planning program.

**Award:** The **\$500** NWAPA Scholarship will be awarded via check directly to the student and may be used to further the student's education in the planning field, such as for tuition, purchase of books or other related educational materials, research-related expenses, and/or conference registration and associated travel expenses.

**Minimum Eligibility Requirements:**

The following have been established as minimum eligibility requirements to apply for the NWAPA Student Scholarship:

- Majoring in the WWU Huxley undergraduate urban planning program
- Academic standing as a Junior or Senior
- Minimum 3.0 GPA
- Intention to work as a planner after graduation
- Familiarity with the American Institute of Certified Planners Code of Ethics
- On-time submittal and completeness of all application materials

A complete application will include:

- **Application form:** See attached.
- **Statement of interest:** Written communication is one of the most important skills that a planner uses. Provide a statement outlining your interest in the planning field. Include your thoughts on

the importance of the planning profession and what you would like to accomplish as a professional planner. (600-word max)

- **Additional relevant information:** Please tell us if you have been involved in volunteer or work activities, your educational history and goals, and other information relevant to your planning experience and interests. Please indicate if you are a member of a population that is underrepresented in the planning profession, if you are a first-generation college student, or if you have served our country in the military or a related capacity. (300-word max)
- **Letters of reference:** All applications must include two signed letters of reference from professors, planners, or employers.
- **Option if minimum requirements not met:** The Northwest Section understands that there may be extenuating circumstances preventing a potential applicant from meeting the minimum eligibility requirements. If you do not meet the minimum eligibility requirements, please provide a brief statement explaining which minimum requirements you do not meet and supporting information as to why your application should still be considered for this award. The Northwest Section will review additional information provided to determine if an application not meeting the minimum eligibility requirements should be scored. (300-word max)

**Review and Selection Process:**

All NWAPA Student Scholarship applications will be evaluated by the Scholarship Committee, which will review and score all applications according to the application evaluation criteria listed below. Additional information may be requested by the Scholarship Committee during the review process and may include an interview. The Scholarship Committee will meet to discuss scores and determine a selection of interviewees or final candidate selection.

Member of an underrepresented population	1
First generation student	1
Military or related service	1

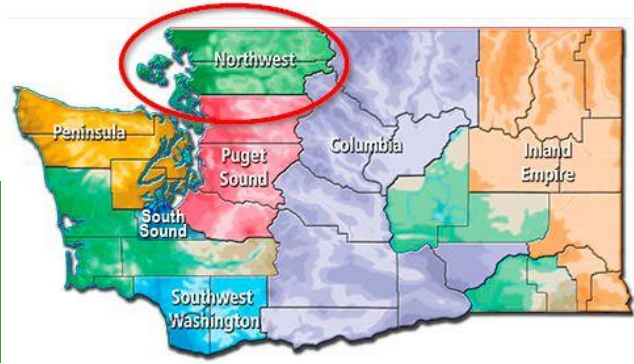
