GOALS, OBJECTIVES, AND INITIATIVES

- 1. Partner with the Washington State Department of Commerce to host quarterly planners forums that serve a broad range of planning professionals
 - 1.1. Include topics that serve tribal, non-profit, and private sector planners
- 2. Provide meaningful communication to and from the Northwest Section membership
 - 2.1. Core message from Northwest Section is to prioritize planning that addresses climate change
 - 2.2. Facilitate communication between NW Section Membership and the APA WA Legislative Committee regarding GMA WAC updates and any future GMA legislative changes.
 - 2.3. Update the Northwest Section webpage at https://www.washington-apa.org/northwest-section as needed, with notifications of updates sent to members.
 - 2.4. Produce quarterly Board Reports for APA Washington that will also be sent to NW Section members.
- 3. Continue to build a strong relationship with the WWU Planning Program that connects our regions strengths in academics and professional practice
 - 3.1. Quarterly outreach activities to WWU classes, Planning Club, and other related clubs
 - 3.2. WWU Student Representative partners with a professor to encourage attendance at planners forums
 - 3.3. Run a scholarship/internship/student representative program
 - 3.4. Engage our local WWU professors to disseminate their knowledge and research via planners forums
- 4. Grow a diverse and inclusive Northwest Section membership
 - 4.1. Provide outreach and education to employers in our region as well as planning commissions regarding the benefits of APA membership and AICP certification.
 - 4.2. Encourage membership among WWU planning students
- 5. Support our AICP candidates, certified planners, and members in their professional development
 - 5.1. Launch an AICP exam study group for members that includes the cost of exam preparation materials at no cost to the individual.
 - 5.2. Continue to offer AICP CE credits for quarterly planners forums
- 6. Convene the Board of Directors as needed
