

## April President's Message

Unlike the last Chapter Board meeting, which was followed by a section holiday party that made my head hurt (in a good way), the March Board meeting was not painful at all. We discussed a number of topics that are important to the chapter and its members.

## **E**DUCATIONAL

• Coordination on the Planning Short Course: Given the importance of community planning education services to the long-term health of the chapter and profession, a number of chapter leaders have been participating with the Planning Association of Washington and the state Department of Commerce on a "Short Course Reboot" to improve content and format. There have been a number of groups that have supported this work, with <u>Association of Washington Cities</u> being among the leaders of the reboot. For the first time, the chapter committed funding to support the course, with a specific focus on creating a digital online version. The Board heard an update

on this topic, and Commerce expressed their thanks for the many hours of involvement from the chapter's members. Finding increased ways to partner on programs with PAW is very promising; stay tuned for future updates.

• Young Planners Group coordination among faculty and student representatives: The Board heard a report from YPG Chair Eric Howard on a conversation among all of the education-related board members. The goal was to identify how the different education-related programs that have seats on the Board are connected, to identify opportunities for increasing communications, and to clarify roles and expectations. These seats have been on the Board for many, many years, and we've not done this before.

For the record, there are tons of connections, such as student scholarships, newsletter articles, student participation and poster sessions at conferences, linkages between universities and the profession to help them retain accreditation, student project profiles in the newsletter, student participation as judges on the awards committee, and student award submissions. We also discussed inviting chapter leadership to present at student functions, getting planning



experience on students' résumés, and perhaps creating an APA Washington internship program where students work for the chapter.

#### April President's Message — APA Washington

• **Coordination opportunities with WASLA (landscape architects):** Again on the theme of coordination, the Board discussed opportunities to coordinate with WASLA. As we've written in past newsletter articles, partnering with allied professions has been a chapter goal for a number of years. Some of the ideas we discussed were joint social events and promoting one another's conferences (because they are at opposite ends of the calendar).

I was excited about this idea at the board meeting. I became even more excited when I spent a sunny afternoon in an Olmsted park with my kid trail running, playing Frisbee and football, and picnicking. I was reminded of how great the landscape architecture profession is although, don't get me wrong, it's certainly not city planning!

If you've got nothing to do on March 27-28 and happen to be in Stanford, you can go to <u>a symposium</u> on Olmstead Parks. If that's too far, you could check out the WASLA <u>annual conference</u> in Seattle on April 8-11 at Magnuson Park.

### ORGANIZATIONAL

• Website Update Task Force: The Board received a great set of recommendations and provided input on updating the website. Broadly speaking, the goal is to make the website content more timely, make advertising and sponsorship more valuable, make the overall structure more user-friendly, and make the website more visually appealing and intuitive. Many thanks to task force chair Kimbra Wellock for her terrific work of this important effort. We will be rolling out changes over the next six months.

• **2014 APA Washington Conference:** The committee is making great progress, and it's time to start getting excited for the conference. They have identified good keynote speakers, are working on the sponsorship opportunities, have released the call for sessions, are beginning to work on the scholarship auction, and I hope are actively working on field testing the pub crawl. And, demonstrating their leadership and responsiveness to member feedback from the 2013 conference, the committee has made the executive decision to not include mushrooms in any of the meals.

• **LEAD** — **Legislative Education, Advocacy and Direction:** The Legislative Committee initiated a new program this year to provide succinct and timely legislative information through our electronic communications. Published about once a week during the session, LEAD provided information on session deadlines, planning-related bills that members should be aware of, and information on how to be involved. The feedback we received from members wwas unanimously positive. This is a great new program and my thanks go to **Esther Larsen, Josh Peters** and **Michael Shaw** for turning this idea into a reality.

• Advertising & Sponsorship Task Force formed: Related to the Website Task Force noted above, the chapter formed a task force to review our approach to advertising and sponsorship. We're pleased to announce that Chad Eiken from the City of Vancouver has graciously agreed to chair the task force and will bring recommendations to the Board at its June meeting. There are a number of

elements to this work—rationalizing advertising rates for the front page, newsletter, and the Planning Firms page; reconsidering whether to use a "menu" rather than "ad hoc" approach; and considering how this relates to section fundraising. This work will inform the related effort to update the website. If you have opinions on the chapter's approach to advertising or sponsorship, please let Chad or me know.



## INDIVIDUAL

• Endorsement of Brian Campbell: Following the chapter and national APA's adopted policies, the chapter's Executive Committee endorsed Brian Campbell—President of APA Oregon—for the National APA Board. As noted in an ADVISE sent in March, Brian has been an effective leader in Oregon and a true partner to the Washington chapter on joint conferences and the Game Changing Initiative. We hope you will support Brian's candidacy with your vote.

• Leonard Bauer is Washington's newest FAICP: As noted in the <u>FAICP Nominations Committee</u> <u>article</u>, Leonard will be inducted into the College of Fellows at the APA National Conference in Atlanta in April. He was selected for acceptance after completing a rigorous nomination application package and after that application was reviewed by APA's National Selection Committee earlier this year. Recognition as a Fellow is the highest honor bestowed on an AICP-credentialed planner.

My thanks go to the FAICP Nominations Committee for their time and support on this project; members included Lisa Verner, FAICP (chair); Norman Abbott, FAICP; Mark Kulaas, FAICP; Michael McCormick, FAICP; and Bill Trimm, FAICP.





## **POSITION STATEMENT**

For the last 8 years I have been involved in efforts to make significant improvements to the planning profession in Oregon, and its impact on the livability of this very diverse state. Oregon has a reputation for being at the forefront of planning practice, but after 40 years our planning system needs updating. There are still many challenges as we confront climate change, resource depletion, economic stagnation and demographic shifts.

As President of Oregon APA I have focused a significant amount of energy, both mine and the organization's, on confronting these challenges more directly. Most significantly, we combined forces with Washington APA and set in motion the Northwest Livability Challenge. This bi-state effort has challenged our planners to create a vision for a more livable future for our states, and to develop new communications tools and significant alliances with other like-minded organizations to help bring about significant institutional and political change that will achieve that vision.

#### **My Priorities**

In the last few years I have used my time in national meetings, especially the Chapter Presidents Council, to advance this livability concept as something that could be replicated by other states and regions. While it

may take very different forms in other areas, the basic concept is to elevate our game as leaders, and more directly address the major issues facing our communities and states. If elected to the Board, I will continue to push national APA to vigorously support these state efforts. I believe that they can provide an important way to actualize APA's Development Plan, and enable local planners to be true guardians of the future for their communities.

Another high priority is to help facilitate the movement of APA toward providing easily accessible web-based planning tools for our members. Especially for those members who work in jurisdictions without the resources to do extensive research, having your professional organization provide that function at minimal cost would be a huge benefit. It is critical that APA stay at the forefront in providing the resources for planners to do their jobs well. A robust, interactive planning research tool is a means to link local planners to a wide range of planning knowledge, especially for the new generation of planning professionals.

## **My Commitment**

As a retired planner with 36 years of professional experience, I will have the time to represent a very large and diverse part of the country by visiting as many states within Region V as possible. If elected I will make a concerted effort to understand the issues of the region's chapters and members, and help find ways for national APA to respond to them appropriately.

## **POSITION STATEMENT**

The five goals and 23 objectives in 2014-2015 APA Development Plan set our course in the right direction. However, the best way to translate these platitudes into a new planning attitude is to elect responsive and creative leaders on the APA board. When I pay my membership dues, I want to be reassured that the value is commensurate with the cost, especially when options to APA are just a "click" away. Equally important as expanding membership and programs is assuring that our current members get the best products and services while containing costs.

I served six years in APA leadership on the Chapter President's Council so I am familiar with how APA is organized and works, and how it could work better. I want to develop more mutually beneficial partnerships with chapters and divisions. I chaired the Chapter Presidents Council Grants Committee and approved many worthwhile and creative proposals from chapters large and small that otherwise couldn't get funded. I think this kind of program needs to be expanded. Being a mentor has provided me the opportunity to guide students and learn about their challenges embarking on careers in planning. I helped establish the Indigenous Planning Division (now part of STAR Division).

I have worked at the city, county and federal levels in planning. I believe there still are great opportunities for APA to play in the years ahead by attracting folks who work for federal agencies and in the private sector.

Since 2008, I have served on the Board of the Western Planning Resources that publishes the Western Planner journal. That organization includes all of the states that are chapters in Region V (except Kansas). This gives me a solid understanding that many of the issues you face may be somewhat different beyond the 100th meridian. It's just different out here.

I believe that planners in Region V have a lot to offer APA, and that planning really matters in protecting the public interest. If you elect me to serve as your representative on the Board, I will work to: provide the services you want; assure transparency; and control operating costs. ## Growth Management expert Leonard Bauer selected as AICP fellow

Leonard Bauer will soon become the APA Washington's newest member of the AICP College of Fellows with his induction at the APA National Conference in Atlanta in April. Recognition as a Fellow is the highest honor bestowed on an AICP-credentialed planner. APA's National Selection Committee selected him earlier this year based on a rigorous nomination application package.

## Legislative Committee Update

The Chapter's Legislative Committee has completed its major work program for the 2014 session and is gearing up to work on legislative issues at the federal, state and local levels with a variety of ongoing programs scheduled through the Interim and leading up to the 2015 session.

## **2014 SESSION SUMMARY**

The 2014 Legislature adjourned a little before midnight on Thursday, March 13, after the House and the Senate agreed to a supplemental operating budget. It ended its 60-day session on time—a big change from last year.

The supplemental budget increased spending by \$155 million, including \$58 million for books, supplies and operating costs in K-12 schools, and \$20.7 million for the mental health system. The budget was unusual in that it did not create or extend any tax exemptions. The House tried to close four tax breaks to pay for cost of living adjustments for teachers, but the Senate would not be persuaded.

The budget did not include additional money to assist jurisdictions with Growth Management Act updates despite a request from Governor Jay Inslee for nearly \$1 million in funding so the Department of Commerce could provide, among other resources, grants to local jurisdictions. The Legislative Committee supported the request for the funding and sent a <u>letter of support</u> to the Governor as well as House Appropriations Committee Chair Russ Hunter and Senate Ways and Means Committee Chair Andy Hill.

Although it passed a supplemental operating and transportation budget, the Legislature failed to pass a supplemental capital budget, which is the first time in Chapter Lobbyist Michael Shaw's 21-year tenure that has occurred. The Legislature also did not pass a transportation revenue package or a medical/recreational marijuana bill. Failure to take the latter action may incur some consequences from the federal government.

The Legislature passed historically few bills, with the House passing 115 Senate bills, and the Senate passing 122 House bills, for a total of 237 bills that reached the Governor. It was a lackluster session for planning bills. In the House Local Government Committee, where most of the land use bills are heard, only six bills survived the process. In the Senate Government Operations Committee, which hears a wider assortment of legislation, 26 bills made it to the Governor's desk, including the six from the House Local Government Committee. Only two bills concerning the GMA passed.

The following list details bills that passed and are of interest to APA Washington members:

• <u>1090</u>: This bill increases the dollar threshold for the construction of certain docks in fresh waters, below which the dock construction is not considered a "substantial development" subject to the permitting requirements under the Shoreline Management Act.

• <u>1224</u>: After 17 years of trying, the counties passed an opt-out bill from the Growth Management Act. This bill applies only to the counties of Garfield, Pend Oreille, Columbia and Ferry. If they are deemed in compliance with certain provisions of the GMA, they can petition to opt out of the voluntary planning under the GMA. This ability sunsets in 2015.

• <u>1260</u>: A Department of Commerce request legislation, this bill directs the Community Economic Revitalization Board to manage the Public Facilities Construction Loan Revolving Account so as to ensure its sustainability. It directs that funds be obligated to public facilities projects under three

existing programs and other legislatively-authorized programs, subject to certain threshold requirements and prioritization criteria. Also, it sets standards for deferral of loan repayments.

• <u>1360</u>: This bill extends the date to designate industrial land banks, with the longest extension being to December 31, 2016, depending on when counties are required to complete comprehensive plan updates.

• <u>2105</u>: This bill promotes transparency in government by requiring public agencies with governing bodies to post their agendas online in advance of meetings.

• <u>2192</u>: This bill requires state agencies to track and record performance data regarding permit timelines.

• <u>2636</u>: A Department of Ecology request bill, this legislation streamlines certain environmental reports by DOE.

• <u>5875</u>: This bill extends the sunset for the homeless housing surcharge that is paid when real estate documents are filed. The sunset was extended until 2019.

• <u>6330:</u> This bill allows rural counties to offer a property tax exemption for multi-family housing projects within unincorporated urban growth areas. It also requires the Joint Legislative Audit and Review Committee to assess the performance of the tax preference with reference to the intent and public policy objective.

The <u>complete bill tracking list</u> that the Legislative Committee used during the session includes the "dead bills" that didn't survive the legislative process (i.e., either died in committee, failed to get a floor vote, or failed to get sufficient support in either chamber).

The 2015 session will start with high expectations and will be particularly tough: It will need to raise billions of dollars for K-12 funding to meet the court-ordered obligations under the McCleary case, pass a transportation revenue package, and address the marijuana issue. The biennial budgets will not get any easier, as there is much still to address concerning mental health services and other safety net concerns. Everything left undone during the 2014 session will come back to roost.

## **SPECIAL COMMUNICATIONS FOR APA WASHINGTON MEMBERS**

Beginning with the 2014 session, the Legislative Committee developed a new tool to communicate with Chapter members during legislative sessions. The committee sent LEAD: Legislative Education, Advocacy and Direction—Close to the Ledge articles six times during the 2014 Session to provide the membership with succinct and timely information regarding bills and other legislative news. The first article went to all of the individuals and entities who are on the Chapter's list serve, and the five following articles went only to the membership. The articles also were featured on the Chapter's website under the "News" section and then archived to the committee's webpage. The committee will use this tool between legislative sessions to inform the membership about significant items outside of the normal Chapter newsletter publication timing. During this year's session, we received a number of kudos and some constructive feedback regarding the first set of LEADs. In the spirit of continual improvement, please feel free to contact the LC co-chairs and/or the Chapter office anytime with comments about the LEAD articles.

## **NATIONAL APA COORDINATION, RESOURCES**

National APA provides a <u>quarterly legislative webinar</u> to brief members on legislative issues, priorities and other work programs. These webinars relate primarily to federal legislation that impacts planning at all levels and provide resources for local chapters in developing their own legislative agendas and to seek input from local chapters on policy guides developed periodically by National APA.

During the most recent webinar on February 27, National APA staff discussed the two newest Policy Guides on <u>Aging in the Community</u> and <u>Hazard Mitigation</u>, which will be presented on April 26 to the Delegate Assembly at the National APA Conference. In addition, the webinar covered the results of a survey of 2014 priority policies of the state chapters.

The results of the survey were:

## **Top Five State Policies:**

1. Improve the resiliency of the state's communities and infrastructure

2. Assist communities to revitalize neighborhoods and foster new strategies for economic and community development

3. Reduce state interference in local planning authority (e.g. attacks on planning)

4. Support innovative and efficient planning as an essential component of community development, infrastructure, and energy programs

5. Improve planning-enabling legislation

- 6. Promote use of green infrastructure to meet state requirements

- Providing the membership with the opportunity to participate in proposing bills for the 2015 session via the bill proposal process
- Updating the Chapter's legislative agenda based on survey data from the membership and coordination with the Ten Big Ideas work groups
